Notice Concerning Partial Change to Unitholder Benefits Program

Nippon Healthcare Investment Corporation (the "Investment Corporation") hereby announces that it has decided to partially change the content of the unitholder benefit program for the 8th fiscal period (the fiscal period ending April 2018) announced in "Notice concerning Determination of the General Outline of the Unitholder Benefits Program" dated March 30, 2018. Details are as follows.

1. Reason for the Change

Sompo Care Inc. (formerly Sompo Care Message Inc.) and SOMPO Care Next K.K. have requested that, in line with the merger on July 1, 2018, they would like to review and change the content of the unitholder benefit programs provided by each separately, in order to make them easier to understand and more fulfilling. Accordingly, the content will be changed as follows.
