GK DA Healthcare 2 (the "Company") has been categorized as "specified related party" (a party engaged in the transactions set forth in Article 29-3, Paragraph 3, Item 1 and Item 2 of the Order for Enforcement of the Financial Instruments and Exchange Act) as of May 1, 2019. The total amount paid by the Investment Corporation, for the acquisition of real estate trust beneficiary interest, to the Company over the previous three years as of the end of the April 2019 fiscal period (from November 1,2018 to April 30, 2019) has exceeded 20 percent of the Investment Corporation's total payment amount for acquisitions or total amount received for dispositions of real estate assets and/or real estate trust beneficiary interests.
